

# **St Joseph's NS Leitrim Village Covid-19 Health & Safety Risk Assessment and Response Plan**

In line with the requirements of Safety, Health and Welfare at Work Act 2005 (Section 19), it is the policy of the Board of Management of St Joseph's NS Leitrim Village to address significant hazards and risks in the workplace, to assess the risks to safety, health and welfare, to control these risks as far as is reasonably practicable, and to provide as safe and healthy a workplace as possible for all staff and as safe a learning environment as possible for all pupils, in accordance with DES guidelines. This risk assessment includes all relevant updates and necessary control measures to minimise the risk of exposure to Covid-19 and involved consultation with all school staff. It is envisaged that additional reviews will be undertaken on a regular basis and in line with government and public health advice to ensure that all information remains accurate, that controls are appropriate and where necessary risks are reassessed.

The guidance issuing from the Department of Education and Science as part of the Roadmap for Reopening has been underpinned by the recommendations of the Health Protection Surveillance Centre and the Chief Medical Officer. The response to confirmed cases or outbreaks of Covid-19 in a school is the responsibility of and will be led and managed by Public Health HSE. All decisions as to appropriate actions following a confirmed case or outbreak will be made by their teams in the context of a full Public Health Risk Assessment procedure. Any actions to be taken by the school will be communicated directly by Public Health HSE. School management will be informed as and when such actions such as exclusion of children or staff; partial or full closure, are deemed necessary on public health grounds. If the school is not so informed, it has not been deemed necessary by Public Health.

## **Hazard:**

A hazard is anything with the potential to cause harm to the safety, health or welfare of staff, students, visitors and contractors.

## **Risk:**

A risk is the likelihood that someone will be harmed by a hazard and the severity of that harm.

## **Control Measures:**

A control measure is an applied measure that reduces the level of risk.

## **Control Measure Principles:**

Schedule 3 of the Safety, Health and Welfare at Work Act 2005 lists the Principles of Prevention. The Board of Management, Principal and School Staff undertake to apply these principles (where practicable) in dealing with all risks within the school:

- Avoidance of risks

- Evaluation of unavoidable risks
- Combating of risks at source
- Adaptation of work to the individual
- Adaptation of workplace to technical progress
- Replacement of dangerous articles, substances or systems of work by safe/less dangerous articles, substances or systems of work
- Priority to collective protective measures over individual protective measures
- Development of an adequate prevention policy which takes account of technology, organisation of work, working conditions, social factors and the influence of factors relating to the working environment
- Appropriate training and instructions to employees.

When the safety audit identifies hazards, it is necessary to evaluate and rank them so that they can be controlled in an orderly way. The risk of a hazard is a measure of the likelihood or probability of an accident coupled with the severity of the injury or loss. The risk potential of each hazard was assessed (by ranking) by giving numerical values of between 1 and 5 to both the **severity** of the consequences and the **probability** of the event occurring. When the severity numerical factor and the probability numerical factor were multiplied together, they produced a number between 1 and 25 thereby producing the numerical values outlined in **risk rating** chart below.

### Risk Rating

Numerical Value Severity x Probability	Descriptive risk rating	Interpretation
16 – 25	<b>Emergency</b> If an incident were to occur, it would be likely that a permanent, debilitating injury or death would result	Risks are unacceptable and immediate action required justifying special maintenance. Activity should be halted and stopped until the hazard is eliminated or appropriate risk controls are put in place.
11 – 15	<b>Serious</b> If an incident were to occur, it would be likely that an injury requiring medical treatment would result.	Activity can proceed but substantial efforts should be made to reduce the risk. Risk reduction measures should be implemented urgently and it might be necessary to consider suspending or restricting the activity.
6 – 10	<b>Medium</b> If an incident were to occur, there would be some chance that an injury requiring First Aid treatment would result	Activity can proceed but consideration should be given as to whether the risks can be lowered. Control measures must be monitored and reviewed as required to ensure they remain suitable and sufficient.
1 – 5	<b>Trivial</b> If an incident were to occur, there would be little likelihood that an injury would result	No additional controls are necessary as these risks are considered acceptable. Activity should be regularly reviewed to ensure there is no change to the risk rating and that controls are maintained.

#### People at very high risk from Covid-19 (extremely vulnerable):

- are over 70 years of age - even if fit and well
- have had an organ transplant
- are undergoing active chemotherapy for cancer
- are having radical radiotherapy for lung cancer
- have cancers of the blood or bone marrow such as leukaemia, lymphoma or myeloma who are at any stage of treatment
- are having immunotherapy or other continuing antibody treatments for cancer
- are having other targeted cancer treatments which can affect the immune system, such as protein kinase inhibitors or PARP inhibitors
- have had bone marrow or stem cell transplants in the last 6 months, or who are still taking immunosuppression drugs

- have severe respiratory conditions including cystic fibrosis, severe asthma, pulmonary fibrosis, lung fibrosis, interstitial lung disease and severe COPD
- have a condition that means they have a very high risk of getting infections (such as SCID, homozygous sickle cell)
- are taking medicine that makes you much more likely to get infections (such as high doses of steroids or immunosuppression therapies)
- have a serious heart condition and are pregnant

Spread of Covid-19 virus	Pupils Staff	Medium	<p><b>Pupils</b></p> <ul style="list-style-type: none"> <li>✓ Advise parents not to bring their children to school if the child has symptoms of a viral respiratory infection or if there is someone in the household suspected or known to have Covid-19.</li> <li>✓ Advise parents not to bring their children to school if they have been identified as Covid-19 contacts.</li> <li>✓ Ensure that pupils are aware that if they develop signs or symptoms when at school they should let their teacher know.</li> <li>✓ It is unlikely to be practical to ask pupils to declare that they are symptom free on arrival to school. Parents, however, should be advised that the school reserves the right to decline entry to pupils who appear to have fever or respiratory tract infection.</li> <li>✓ On-site temperature taking is not recommended because fever is not a consistent symptom of Covid-19 in children and would result in delayed school entry.</li> <li>✓ Ensure that up-to-date contact details for parents/guardians are available so that they can be contacted to collect pupils from school in the event of illness.</li> </ul> <p><b>Staff</b></p> <ul style="list-style-type: none"> <li>✓ No employees are permitted to attend work if they display any of the symptoms below: <ul style="list-style-type: none"> <li>- Fever (temperature of 37.5 degrees or above)</li> <li>- Cough</li> <li>- Shortness of breath or breathing difficulties</li> <li>- Loss of smell, of taste or distortion of taste</li> </ul> </li> <li>✓ Any staff member displaying symptoms must self-isolate and not attend school for 14 days.</li> <li>✓ Any staff member living with someone who is self-isolating or waiting for a Covid-19 test must restrict their movements for 14 days.</li> <li>✓ Any staff member who has tested positive for Covid-19 must not return to work until deemed fit to do so and upon approval of their medical advisor.</li> <li>✓ Staff can follow <a href="https://www2.hse.ie/">https://www2.hse.ie/</a> for regular updates or can contact HSELive for advice <b>1850 241850</b></li> </ul>	Principal Staff

Spread of Covid-19 virus	Pupils Staff Visitors	Medium	<ul style="list-style-type: none"> <li>✓ Everyone entering the building will be required to perform hand hygiene with a hand sanitiser. This may need to be supervised.</li> <li>✓ Staff and pupils should understand why hand hygiene is important, when to wash their hands and how to wash their hands.</li> <li>✓ Promotion of good hand hygiene and the displaying of posters throughout the facility (available on the HPSC website).</li> <li>✓ Hand hygiene will be achieved by handwashing or use of a hand sanitiser.</li> <li>✓ Care will be taken to clean up any hand sanitiser spills to prevent risk of falls.</li> <li>✓ Use of hand hygiene facilities including wash hand basins needs to be managed so as to avoid congregation of people waiting to use wash hand basins and hand sanitiser.</li> </ul> <p><b>Handwashing facilities (to the greatest extent practical)</b></p> <ul style="list-style-type: none"> <li>✓ Should be adequate to meet the needs of the school population and should be age/ability appropriate. Hand sanitiser can be used to bridge the interval until sufficient handwashing facilities can be provided or upgraded.</li> <li>✓ Wash hand basins, running water, liquid soap dispensers and hand drying facilities will be provided in all toilets and staff room.</li> <li>✓ Handwashing facilities will be maintained in a good condition</li> <li>✓ Cleaning staff will be reminded to check the soap dispensers at frequent intervals.</li> <li>✓ Wash hand basins are at an appropriate height for staff and pupils of all ages.</li> <li>✓ Shared towels will not be used.</li> <li>✓ Paper towels in wall-mounted units are preferable.</li> <li>✓ Hot-air hand dryers are an acceptable alternative. If hand dryers are provided they must be regularly maintained.</li> <li>✓ Posters displaying handwashing technique and promoting handwashing will be placed on the wall adjacent to washing facilities (these can be downloaded free from <a href="http://www.hpsc.ie">www.hpsc.ie</a> and laminated or placed in a plastic sleeve).</li> </ul> <p><b>Handwashing products</b></p> <ul style="list-style-type: none"> <li>✓ Liquid soap and running water will be provided.</li> <li>✓ A mild unscented liquid soap is preferred especially for staff and pupils with sensitive skin.</li> <li>✓ Disposable cartridges of liquid soap that are wall mounted are preferred.</li> </ul>	Board of Management Principal Staff Pupils Visitors

			<ul style="list-style-type: none"> <li>✓ If the liquid soap container is refillable, the container and pump should be emptied, cleaned, and dried completely before being refilled.</li> <li>✓ Soap and water must be used if hands are visibly soiled.</li> </ul> <p><b>Hand sanitiser – Alcohol-Based Hand Rubs</b></p> <ul style="list-style-type: none"> <li>✓ Hand sanitiser is suitable for use for hand hygiene when hands are not visibly soiled</li> <li>✓ Evidence of effectiveness is best for alcohol-based hand rubs but non-alcohol-based hand rubs are available and may be preferable in some settings</li> <li>✓ Alcohol-based hand rubs are flammable and can be toxic if ingested.</li> <li>✓ Where hand rubs/gels are used in the school setting, care should be taken to ensure that children do not accidentally ingest the products.</li> <li>✓ Young children should not have independent use of containers of alcohol gel.</li> </ul> <p><b>Frequency of hand hygiene</b></p> <ul style="list-style-type: none"> <li>✓ Pupils and staff should perform hand hygiene <ul style="list-style-type: none"> <li>- On arrival at school</li> <li>- Before eating or drinking</li> <li>- After using the toilet</li> <li>- After playing outdoors</li> <li>- When their hands physically dirty</li> <li>- When they cough or sneeze.</li> </ul> </li> <li>✓ Pupils and staff should learn how to perform hand hygiene with an effective technique.</li> <li>✓ Opportunities to perform hand hygiene will be provided and good technique encouraged.</li> </ul>

Spread of Covid-19 virus	Staff Visitors	Medium	<ul style="list-style-type: none"> <li>✓ The correct use of Personal Protective Equipment (PPE) such as face shields/visors or clear plastic barriers or Perspex screens etc. may be required in some circumstances to address identified risks of spread of the virus.</li> <li>✓ Where PPE is required by staff, they will be notified accordingly and be provided with the necessary PPE and provided with training and information in the proper use, cleaning, storage and disposal of PPE.</li> <li>✓ PPE needs to be consistently and properly worn when required. In addition, it must be regularly inspected, cleaned, maintained and replaced as necessary.</li> <li>✓ PPE (apart from face coverings for staff) will not be required to be worn within the school facility according to current occupational and public health guidance.</li> <li>✓ Current general guidance from the HSE in relation to the wearing of face coverings, masks and gloves is available at the following link: <a href="https://www2.hse.ie/conditions/coronavirus/face-masks-disposable-gloves.html">https://www2.hse.ie/conditions/coronavirus/face-masks-disposable-gloves.html</a></li> </ul> <p><b>Wearing of Face Coverings</b></p> <ul style="list-style-type: none"> <li>✓ Non-medical face coverings may reduce transmission from individuals who are shedding the virus. However, the extent of this benefit is unknown (especially in children) and would only be potentially beneficial if done properly. Staff will wear face coverings. It is not practical for many students to wear a mask properly for the duration of a school day. Cloth face coverings are not suitable for children under the age of 13.</li> <li>✓ Wearing a face covering or mask does not negate the need to stay at home if symptomatic.</li> </ul> <p><b>Wearing of Gloves</b></p> <ul style="list-style-type: none"> <li>✓ The use of disposable gloves in the school setting by pupils or teachers is not appropriate. It does not protect the wearer and may expose others to risk from contaminated gloves. Routine use of disposable gloves is not a substitute for hand hygiene. Washing or use of hand sanitiser on gloved hands is not appropriate.</li> <li>✓ Measures will be introduced to reduce the need for pupils/teachers to physically touch common objects/doors, e.g., by installing no-touch waste containers, propping doors open, hand towels.</li> </ul>	Board of Management Principal Staff Visitors

Spread of Covid-19 virus	Staff Caretaker Cleaners	Medium	<p><b>General</b></p> <ul style="list-style-type: none"> <li>✓ All cleaning will be undertaken in line with DES and public health guidance.</li> <li>✓ Staff members are responsible for cleaning personal items that have been brought to work and items handled at work or during breaks.</li> <li>✓ Cleaning staff will be trained in the new cleaning arrangements for the school.</li> <li>✓ Sufficient cleaning materials and PPE will be available to allow for increased</li> </ul>	Board of Management Principal Staff Caretaker Cleaners

		<p>Serious</p>	<p>cleaning.</p> <ul style="list-style-type: none"> <li>✓ Cleaning staff will be instructed to wear gloves when cleaning and are aware of the need to wash their hands thoroughly with soap and water, both before and after wearing gloves.</li> <li>✓ The manufacturer’s instructions for mixing, using and storing solutions must always be followed.</li> <li>✓ Using excessive amounts of cleaning agents will not kill more germs or clean better but it will damage work surfaces, make floors slippery and give off unpleasant odours.</li> <li>✓ Water should be changed when it looks dirty and after cleaning toilets.</li> <li>✓ Always clean the least dirty items and surfaces first (e.g., countertops before floors, sinks before toilets).</li> <li>✓ Always clean high surfaces first, and then low surfaces.</li> <li>✓ Separate colour coded cleaning cloths and cleaning equipment should be used for kitchen areas, classrooms and toilets.</li> <li>✓ Cleaning cloths can either be disposable or reusable. Disposable cloths should be disposed of each day.</li> <li>✓ Ideally, reusable cloths should be laundered daily on a hot wash cycle (at least 60°C) in a washing machine and then tumble dried.</li> <li>✓ Ideally, mop heads should be removed and washed in the washing machine at 60°C at the end of each day or in accordance with the manufacturer’s instructions.</li> <li>✓ Mop heads/buckets should not be cleaned in a sink that is used for food preparation.</li> <li>✓ Mop heads should not be left soaking in dirty water.</li> <li>✓ Buckets should be emptied after use, washed with detergent and warm water and stored dry.</li> <li>✓ If equipment is stored wet, it allows germs to grow increasing the risk of cross infection.</li> <li>✓ Waste bins should be emptied on a daily basis.</li> </ul> <p><b>Following a Suspected or Confirmed Case of Covid-19</b></p> <ul style="list-style-type: none"> <li>✓ It is recommended that an area be cleaned with normal household disinfectant after a suspected Covid-19 case. This will reduce the risk of passing the infection on to other people.</li> <li>✓ For cleaning purposes, wear a face mask and gloves. These should be double-bagged, stored securely for 72 hours and then put with the regular rubbish after cleaning is finished.</li> <li>✓ Using a disposable cloth, first clean hard surfaces with warm soapy water. Then disinfect these surfaces with the cleaning products you normally use. Pay</li> </ul>

			<p>particular attention to frequently touched areas and surfaces, such as toilets, and door handles.</p> <ul style="list-style-type: none"> <li>✓ If an area has been heavily contaminated, such as with visible bodily fluids, from a person with Covid-19, consider using protection for the eyes, mouth and nose, as well as wearing gloves and an apron.</li> <li>✓ Wash hands regularly with soap and water for 20 seconds and after removing gloves, aprons and other protection used while cleaning.</li> <li>✓ Public areas where a symptomatic individual has passed through and spent minimal time, such as corridors, but which are not visibly contaminated with body fluids can be cleaned as normal.</li> <li>✓ All surfaces that the symptomatic person has come into contact with must be cleaned and disinfected, including objects which are visibly contaminated with body fluids.</li> <li>✓ Use disposable cloths or paper roll and disposable mop heads to clean all hard surfaces, floors, chairs, door handles and sanitary fittings, using an approved and recognised detergent and disinfectant in line with the manufacturer's instructions for dilution, application and contact times.</li> <li>✓ Avoid creating splashes and spray when cleaning.</li> <li>✓ Any cloths and mop heads used must be disposed of.</li> <li>✓ When items cannot be cleaned using detergents or laundered (e.g., upholstered furniture) steam cleaning should be used.</li> <li>✓ Any items that have been heavily contaminated with bodyfluids and that cannot be cleaned by washing should be disposed of.</li> <li>✓ Waste should be put in a plastic rubbish bag and tied when full, the plastic bag should then be placed in a second bin bag and tied. It should be put in a suitable and secure place and marked for storage until test results are known or for at least 72 hours before being put with normal waste.</li> </ul>
